## Abstract

The status of women in joint family is low as compared to women in nuclear family. In nuclear family women do get opportunities to rise up. The mother in law can be a horrifying factor for a daughter in law. The status dilemma severely starts after marriage. A woman becomes a bundle of responsibilities without rights most of the time.
